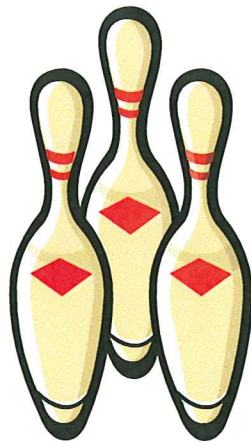
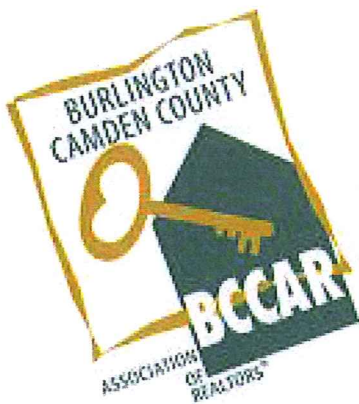

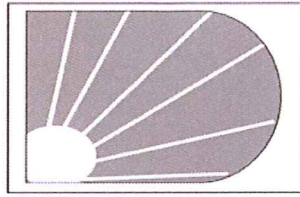

HISTORY and OVERVIEW

WHO WE ARE

- A private, non-profit (IRS 501-C-3), non-sectarian community organization founded by 9 Moorestown Churches in **1969**.
- Governed by a 15-person, volunteer Board of Trustees
 - 9 are representatives of the founding churches;
 - 6 are at-large representatives of the community
 - **5 at-large Trustees are MEND Tenants**
- State/County-certified Community Housing Development Organization.

WHAT WE DO (Our "Mission")

Provide rental and for-sale housing in the Burlington County region to low and moderate income individuals, families, senior citizens and the disabled who need a decent, safe, affordable place to call home.

HOW WE DO IT

- Develop, build, own, manage and maintain rental housing for low and moderate income tenants; have also built and sold single-family homes to low/moderate income owner-occupants.
- Own and manage **28 residential rental properties**, primarily in scattered-site developments, encompassing
 - **260 apartment units**
 - 460+ residents
 - half of all the apartments are for the elderly
- Employ a staff of 8 affordable housing professionals.

WHERE WE ARE GOING

- Expanded into Delanco with the acquisition of a 10-unit, low/moderate income apartment development in 2003.
- Completed a new 8-unit rental project (Creed II) in Moorestown in 2007, including 4 units for the physically disabled.
- Currently building a new 104-unit family rental project on Sharp Road in Evesham
- Currently developing other affordable rental properties in Medford (36 units) and Southampton (37 units).
- Looking for joint-venture and partnership opportunities in the region with municipalities and housing developers that have affordable housing needs.
